Part I (This date will be arranged by the GSI):

- **Solo repertoire:** Choose one from the list provided by the GSI—Memory not required
- Scales in Tetrachord Position: Play 4 major scales in tetrachord position (pp. 108-111) Video Submission due on 10/19 at class time [penalty for not turning the exam in time: 4 points off per day for late video submission]
- Chord Progression: MAmd chord progression descending chromatically from C through G—Memory not required (p. 98) Video Submission due on 10/19 at class time [penalty for not turning the exam in time: 4 points off per day for late video submission]

Part II (with Prof. Ellis or Dr. Braaksma):

- **Sight-reading:** Appropriate to the level of examples covered through mid-term and including Unit 7.
- Harmonization/Transposition: Appropriate to the level covered up to and including Unit 7. You will provide a single-note accompaniment in the left hand to a melody. The notes will either be the tonic or dominant scale degrees. You will have a chance to play the melody through once to hear it and think about it. You will then be asked to transpose up or down a M2.

Final Examination Requirements:

Part I (This date will be arranged by the GSI):

- **Solo repertoire—BY MEMORY**: A solo piece of student's choice from Units 9-13 or from Supplementary Solo Repertoire (pp. 325-346).
- **Chord Progression:** Play the I-IV6/4-I-V6/5-I Chord Progression, block chords in both hands (p. 170) **Video Submission due on 12/9 at class time** [penalty for not turning the exam in time: 4 points off per day for late video submission]
- Scales and Arpeggios: Major Scales Hands Together and Arpeggios Hands Apart, 2 octaves in white key major keys selected by the jury at the test. You should be prepared to play all of them. GSI will choose the keys for you to play Video Submission due on 12/9 at at class time [penalty for not turning the exam in time: 4 points off per day for late video submission]

Part II (with Prof. Ellis or Dr. Braaksma):

- **Sight-reading:** Appropriate to the level of examples covered through mid-term and
- Harmonization/Transposition: Use block chords of I, IV6/4, and V6/5 when appropriate. You will have one chance to play through the melody.
